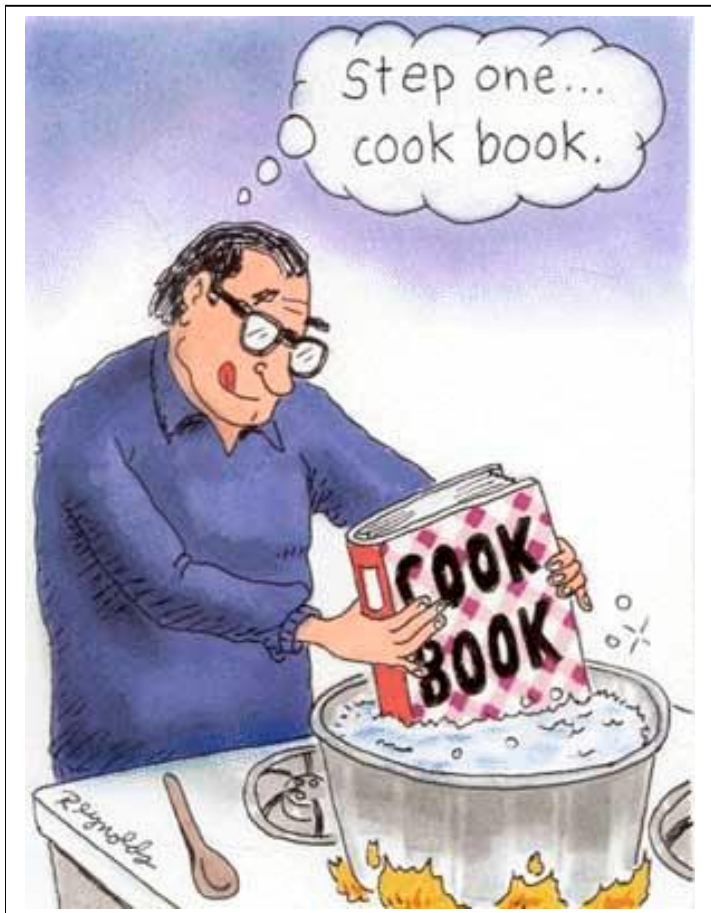


Mark Perew (left) and Barbie Morgan were the winners at the Area 21 competition. Both are members of Northwestern Toastmasters.
